- 4. It is requested that Indian High Commission/ Embassy in **Jiangsu (China)** and organizers of the event may please be informed of the travel plans and itinerary of the delegation for participation in above event. The team members may be advised to call on the Mission for exchange of views.
- 5. A report on the visit of the team along with its **performance / achievement** in the above Event may please be sent to TEAMS Division, SAI within 7 days of the return of the team to India along with **some action photographs**, if possible.

- 6. Before departure of the team, Indian Wushu Team Coach (Mr.Amit Pal) may please have the report of Dope Test of members of the team from NADA, If Necessary.
- 7. Selection policy is not updated on the W.A.I. portal, but considering the welfare of athletes Admin sanction can be issued for this event. However, if the selection policy is not updated on W.A.I. portal then the further proposal might not be processed.
- 8. Admin sanction can be issue without Women Coach. However, in the further proposal might not be proceed without women coach.
