Medical expenditure on actual basis provided the said injury is not covered under Insurance. However Regional Center may incurred the expenditure immediately and claimed the same amount from Insurance agency. Subsequently a separate record is maintained in such cases by the concern Regional Center.

- The Regional Center/Organizer to make all the necessary arrangements for the camp sanctioned, per the norms/approved by the Competent Authority.
- A list of campers reported for the camp should be forwarded to the TAGG Division immediately after 2nd day from the commencement of the camp.
- Any inclusion/deletion of National Coaching Campers should not be entertained without prior approval of the TAGG Division.
- On conclusion of the Coaching Camp, the Regional Center shall submit a report on the coaching camp within 10 days to the TAGG Division, New Delhi..
- 5. The Expenditure may be debited under the head of Financial Assistance to NSFs.
- 6. Food Supplements will be procured and distributed by the NSF as per norms.
- Facial Attendance in the National Coaching Camps is mandatory. The Regional Centre/Head Coach attached to the team is requested to ensure the facial attendance of all campers.
- 8. Travel Sector: HOME- CAMP & BACK.
- Disturbance allowance of the coaches & Salary of Physio to be paid by TAGG Division on a pro-rata basis after approval of the empanelment of coaches and support staff.
- Medical insurance to be done through SAI head Quarters, New Delhi.
- Physiotherapy Consumable equipments to be procured by NIS Patiala for the NCC.
 This issues with the approval of the Competent Authority.
