

1. Section 9 of FC (R) Act, 1976, provides inter – alia that no member of a legislature, office bearer of a political party, judge, Government servant or employee of any corporation shall accept any foreign hospitality without the prior permission of the Central Government. In case, any team member is covered under the above act, he/ she obtain the prior permission from Ministry of Home Affairs before their departure to **Moscow (Russia )**
2. As regards foreign exchange required for above participation, **Indian Wushu Team, WAI** is requested to approach authorized dealers for getting the foreign exchange in view of RBI circular No. 41 A.D (M.A. Series) dated 25.1.97.
3. Such of the team – member who might be Central Government Servants are to be treated as on duty (Which include deputation abroad) in respect of the participation by the Departure / Office in which they are employed in teams of Department Personnel & Training O.M. No. 6/1/85-Est. (Pay-1) dated 30.1.1989 **Indian Wushu Team** (should inform their employing Department/ Office accordingly.

4. It is requested that Indian High Commission/ Embassy in **Moscow (Russia)** and organizers of the event may please be informed of the travel plans and itinerary of the delegation for participation in above event. The team members may be advised to call on the Mission for exchange of views.
5. A report on the visit of the team along with its **performance / achievement** in the above Event may please be sent to TEAMS Division, SAI within 7 days of the return of the team to India along with **some action photographs**, if possible.
6. Before departure of the team, **WAI** may please have the report of Dope Test of members of the team from NADA, If Necessary.
7. Travel Sector: NCC/Home to (Moscow, Russia) and from Moscow, Russia to Home/NCC (as per actuals)
8. Booking of air tickets will be booked by WAI as per Govt authorized agency.
9. **Advance amount has been issued to WAI dated 27-03-2025.**
10. **WAI will select 20 players (M & W ) from the list of 22 players (13M +7 W) selected by WAI in the Senior Athletes category from Sr. No. 1 to 12 and Junior Category Athletes from Sr. No. 13-22.**
