The Wushu Association of India (WAI) will be conducting the Final selection trial for the selection of the Sanda Junior Wushu team to participate in the 10th Junior World Wushu Championship held at Tianjin, China, from 23rd to 31st March 2026.

The Final selection trials for the above-mentioned championships will be held at Rajiv Gandhi Sports Complex, Sector 10, Ambala, Haryana, from 03rd to 04th February 2026.

## **EVENT DETAILS:-**

### **1. THE 10<sup>TH</sup> JUNIOR WORLD WUSHU CHAMPIONSHIP AT TIANJIN, CHINA, FROM 23<sup>RD</sup> TO 31<sup>ST</sup> MARCH 2026.**

- The final trials will be conducted in accordance with the IWUF Wushu Sanda Competition Rules and Judging Method (2024).
- The WAI Selection Committee shortlisted the selected Sanda weight categories and players during the selection trial held at Chhattisgarh from 23rd to 24th December 2025.

### **Selection Trial – Important Guidelines**

- The selection trial will be conducted strictly as per the guidelines of the International Wushu Federation (IWUF).
- The Taolu players have already been selected for the 10th World Wushu Championship during the selection trials held at Manipur from 01st to 02nd December 2025.
- All bouts will be video-graphed for record and review purposes.
- All players must submit the following documents prior to the selection trial:
  - Valid Indian Passport
  - Original Medical Fitness Certificate (issued within the last 15 days)
  - Waiver/Liability Form (duly signed by the parent/guardian)
  - Insurance

*No player will be permitted to participate without the submission of the above documents.*
- No relaxation in weight categories will be permitted during the selection trial.
- A Doping Control Team will be present at the venue. All players are required to cooperate fully and follow the instructions issued by the Doping Control Team. Any complaint, indiscipline, or deviation from rules will be viewed seriously by the Selection Committee.
- All players must bring their own equipment and proper uniforms, as applicable to their respective sides.
- Boarding, lodging, and transportation expenses shall be borne by the athletes themselves.
- All affiliated States/Units are requested to kindly send their shortlisted athletes for the selection trials.
- The list of selected athletes and the Waiver/Liability Form are enclosed herewith.
- In case of injury or any unavoidable circumstances, the final selected athlete shall be replaced by the standby athlete.
