**Sub: The Final selection trials for the Sanda Wushu Team at Rajiv Gandhi Sports Complex, Sector-10, Ambala, Haryana, from 03<sup>rd</sup> to 04<sup>th</sup> February 2026.**

The Wushu Association of India is pleased to inform that the 10th Junior World Wushu Championship (10th JWWC) is scheduled to be held at Tianjin, China, from 23rd to 31st March 2026.

The Wushu Association of India (WAI) has already finalized the Taolu Team during the Selection Trials held at NERC, Imphal, Manipur, from 01st to 02nd December 2025.

Whereas, 24 Sanda athletes were shortlisted during the Selection Trials held at Rajnandgaon, Chhattisgarh, from 23rd to 24th December 2025. The deadline for submission of the final entry for the 10<sup>th</sup> JWWC is 07th February 2026.

In this regard, the Wushu Association of India will be conducting the Final Selection Trials for the Indian Sanda Wushu Team at Rajiv Gandhi Sports Complex, Sector-10, Ambala, Haryana, from 03rd to 04th February 2026, to finalize the Indian Junior Wushu Team for participation in the 10th Junior World Wushu Championship.

The WAI has also proposed to the Sports Authority of India to conduct a National Coaching Camp for 39 selected athletes (comprising 22 Sanda and 17 Taolu athletes), commencing from 05th February 2026, as part of the preparation for the 10th JWWC.
