

1. As per the provisions scheme, the admissible assistance would be provided for the above-mentioned team members only.
- 2 Section 9 of FC (R) Act, 1976, provides inter-alia that no Member of a legislature, office bearers of a political party, Judge, Government Servant or employee of any Corporation shall accept any foreign hospitality without prior permission of the Central Government. In case, any team member is covered under the above Act, he/she should obtain the prior permission from Ministry of Home Affairs before his/her departure to Russia.
3. Such of the team-members who might be Central Government Servants are to be treated as on duty (which include deputation abroad) in respect of this participation by the Department/Office in which they are employed in terms of Department of Personnel & Training O.M. No. 6/1/85-Estt. (Pay-1) dated 30.1.1989. The Federation should inform their employing Department Office accordingly.
4. It is requested that High Commission/Embassy of India at China and organizers of the event may please be informed by fax/email of the travel plans and itinerary of the team for participation in the above event. The team members may be advised to call on the Mission for exchange of view.





6 Before departure, a report on dope test of the team members may please be obtained from DG, NADA New Delhi

7. Travel Sector: Training Venue or Home town to Russia & Back. In this regard, it is also requested to book ticket through any of the three travel agents viz. (i) M/s Balmer Lawrie & Company Limited (BLCL), (ii) M's Ashok Travels and Tours (ATT) and (iii) Indian Railways Catering and Tourism Corporation Ltd. (IRCTC), in terms of Ministry of Finance, Department of Expenditure's OM No. 19024/01/2021 dated 16th June, 2022. Further, the tickets have to be booked immediately on receipt of the sanction
